<u>The Jerusalem Foundation – Privacy Policy</u>

- 1. The contents of this policy document apply to all communication with the Foundation, as well as to all information sent to the Foundation.
- 2. The Jerusalem Foundation (R.A. 58-001280-5) attaches great importance to your privacy, and makes every effort to protect and safeguard all information you send to the Foundation.
- 3. You are not required to provide information to the Foundation. Any information you do provide to the Foundation is solely of your own free will, and will be stored in the Foundation's database. Submission of information constitutes your express consent that it be saved and used by the Foundation according to Foundation policy. Use of the information will be for the sole purpose said information was provided to the Foundation.
- 4. The information submitted and saved by the Foundation includes first name, surname and email address. It will be expressly noted if and when the Foundation saves any other personal information.
- 5. If you are donating funds online for Foundation activities please see section 11 below.
- 6. If you would like to speak with a Foundation representative about the information stored by the Foundation, or feel that your privacy has been violated, or that there is room for improvement, we would be happy to speak with you. If, in the past, you gave consent to the Foundation to store information, but have since changed your mind, or wish to amend the information provided there is no problem at all! The Foundation's contact information appears below, and the Foundation will amend or erase the information at your request.
- 7. Any information about you will serve the Foundation solely and exclusively:
 - 7.1. To stay in contact.
 - 7.2. To provide you with updates about activities and events of the Foundation or its related affiliates, which are being held in Israel or abroad.
 - 7.3. To manage and raise donations.
 - 7.4. To provide you with updates about the Foundation and related affiliates' activities, including updates about donations. You may request removal from these updates at any time, by either sending written notice to the Foundation according to the contact information below, or by using the designated "remove" link in the f the update, as you prefer.
- 8. It may be possible, whether through this website or any other way, to send the Foundation your name, address and various details about yourself, your spheres of interest, the reason for your interest in the Foundation, information regarding your

support for projects in Jerusalem, and more. Should you send such information, as said above, it will be stored by the Foundation and may be accessible to organizations abroad connected with the Foundation (like the Jerusalem Foundation in the United States, the Jerusalem Foundation in Germany, etc.). These organizations work to advance Jerusalem Foundation goals, however, they are legal corporations, independent of the Foundation. Additionally, information you may choose to share with any of the above organizations may be sent by them to the Foundation.

- 9. Subject to all of the above, the Foundation will not share any information about you with any third party, unless required to do so by provisions of any law applying to the Foundation and/or the information and/or for managing and solving legal disputes between you and the Foundation and/or upon demand of a competent authority. Transfer of information as stated is not conditional on the Foundation providing prior notice.
- 10. "Cookies" are information files that serve to verify, monitor and register/store information about the internet surfer, like user identity, preferences, etc. The Foundation website does not use cookies, and does not register/store information about your web surfing. Nonetheless, it is possible that your search engine, telephone, computer, operating system or other websites you visited before reaching the Foundation's website, or sites you reached via the Foundation's website (including Facebook, Instagram, Tweeter and Youtube pages of the Foundation) do collect information about you and use cookies. This information may include your web surfing habits, including the very fact that you showed interest in the Foundation, your IP address, details about your internet provider and additional information. The Foundation is not responsible for this information, and nor is it under the Foundation's control.
- 11. If you choose to donate to the Foundation and press the "DONATE" button, you will be sent to a designated page where you can choose the country where your account will be charged and make a donation. However, please be advised:
 - 11.1. To donate online, certain information must be provided as detailed on the website. Without this information, one cannot donate online. If you prefer, you can always contact us and donate via telephone.
 - 11.2. The Foundation does not save information about your credit card or bank account, and likewise when donating by phone. The Foundation does save the donor's personal information full name, amount donated, address, and any other information the donor was asked to provide and did so willingly.
 - 11.3. Processing payment is not done by the Foundation, but rather by a third party. Information provided in the processing framework, including credit card details, are not sent to the Foundation, but to a processing agent. The Foundation is not responsible for any information sent to the processing agent, nor is this information under the Foundation's control.

- 11.4. If you choose to donate online to the Foundation via web pages of countries other than Israel be advised that relevant laws of said countries may apply, including with regard to the confidentiality of the information sent, and Israeli law will not apply.
- 12. The Foundation's website, its contents and internal links are offered for your use AS IS. The Foundation makes no representations whatsoever regarding the accuracy of the above. The website, the contents and links may include errors, bugs and inaccuracies, and may not work properly on, and/or, over various technological platforms, and may contain malicious content/viruses (even though the Foundation invests great efforts to prevent this). The web pages of corporations abroad connected with the Foundation are not the Foundation's responsibility, and the Foundation bears no liability in their regard.
- 13. All content and data you upload on the internet may be visible to a third party, and a third party may make malicious use thereof and/or in accordance with the directives of any law and/or in violation of the directives of any law. Accordingly, every visitor to the website must exercise extreme caution in terms of everything that involves his/her privacy and personal data. The full and sole responsible for all that is stated above lies with the user.

Declaration on the matter of GDPR and foreign privacy protection laws Since 2011, the European Union recognizes the State of Israel as a country that practices proper privacy protection of personal information sent to Israel from the European Union. Therefore, the transfer of personal information to the State of Israel is permitted according to GDPR regulations. With regard to all that pertains to the protection of privacy, the Foundation operates solely according to the laws of the State of Israel. All communication with the Foundation and/or use of its website are subject solely to the laws of the State of Israel. Nonetheless, if, and to the extent that, foreign privacy protection laws apply to specific Foundation activities, the Foundation will honor the foreign law's provisions for said activity. In the event of activities in Israel and/or regarding organizations in Israel and/or in any dispute or disagreement on the question of whether Israeli or foreign law applies Israeli law will prevail.
