## FROM THE PRESIDENT

### Dear Friends,

October 7, 2023 changed our lives. Any summary or planning for the coming year and the years ahead stands in the shadow of the war. It would be strange to summarize this year as a success story, given the war's horrific events and long-term effects on Jerusalem, Israel and the world.

The Jewish philanthropic world is changing before our eyes, certainly in the immediate short-term future and coming year. The galvanization of world Jewry (and non-Jewish Israel supporters) to provide vital support and immediate response to emergency needs, some of which are basic needs not addressed by the philanthropic world in recent years, and on a much more significant scope, instantly changed priorities.

The key to our ability to rapidly raise funds for the emergency was most importantly due to the trust and momentum that the Jerusalem Foundation has built up over the past few years. This led to the expansion of our regular activities and allowed us to create an Emergency Fund already starting on October 8, 2023. This put us in a position to respond to the most urgent basic needs that were emerging because of the war, while adapting on a daily basis to changing needs. Since October 8th, the Jerusalem Foundation has raised approximately \$10 million for the Emergency Fund.

In the first few days after its establishment, the Fund concerned itself with offering assistance to tens of thousands of evacuees from frontline communities to Jerusalem and to the city's most needy and vulnerable populations. With the prolongation of the state of emergency, our "Double Impact" initiative, which aims to connect the many evacuees who have arrived in Jerusalem and the most vulnerable populations in the city, with our city's cultural institutions, became the flagship project of the Emergency Fund. The project provides cultural, educational and respite activity for the evacuees and residents (primarily for children and youth), thus also providing support to the Foundation's anchor institutions, which have experienced dire economic difficulties and challenges due to the war.

The work of the Jerusalem Foundation over these past years, creation of a network of civil society organizations, development of civil leadership in the city – proved itself to be essential during the emergency. It was these same organizations and young leaders, who we have supported and nurtured for many years, that stood on the frontline of providing solutions and responding to immediate needs for so many people in the city and the refugees. With the failure of government and public agencies to respond, it was very clear that the civil society network developed and supported by the Jerusalem Foundation was able to step up and provide answers and hope.

Prior to the war, 2023 was becoming a peak year for fundraising for the Jerusalem Foundation. The Foundation raised more than \$61 million for projects and programs in Jerusalem and conducted projects and programs in Jerusalem expending more than \$41 million in 2023 and the remaining funds will be spent on major capital projects and programs in the years to come.

With a broad perspective of Jerusalem Foundation activity in recent years, particularly this past year, there is much to be proud of. Repositioning the Jerusalem Foundation as a major player in Jerusalem by spearheading significant projects and programs in the city and working in full cooperation with the Mayor and the Municipality, has brought the Foundation to new heights.

The core spheres of activity of the Jerusalem Foundation's "Jerusalem 2030" vision – Future Leadership, Communal Strength and Creative Culture, with emphasis on Shared Living and providing equal opportunities to all – have become even more relevant during this time of emergency and for coping with the "day after".

These spheres of activity will form the basis for coping with the long-term challenge, as well as the basis for presenting the Jerusalem Foundation's up-to-date vision for the "day after" and the enormous challenges with which Israeli society will have to contend, with the City of Jerusalem at the center.

Jerusalem was not at the center of events on October 7th but became central very soon after and will continue to be in focus in the longer-term "day after". The Jerusalem Foundation has a critical role in spearheading long-term measures: The "day after", Jerusalem as a leading city that presents the solution, rather than the problem.

There are three important subjects which will put Jerusalem in focus the "day after": Shared Living – how to rebuild the trust between the city's diverse communities; Future Leadership – wartime leadership crisis highlighted the need for civil society leadership; Strengthening resilience and long-term trauma treatment – this is a topic that will concern the entire population of Israel.

The Jerusalem Foundation must simultaneously continue planning its flagship projects, which were put aside from our list of immediate priorities, but they have a critical role in shaping the city long term, such as upgrading Sultan's Pool, expanding the Bloomfield Science Museum, completing the development of the Gazelle Valley Urban Wildlife Park, establishing a nature preservation and environmental protection education center and more. In the long term, the great challenge faced by the Jerusalem Foundation will be to lead the development of projects and programs for the "day after" over the course of 2024, which will continue to be relevant in the coming years.

I wish to express profound gratitude to the Jerusalem Foundation leadership and staff, and our professional teams around the world, who have contributed to this significant growth in fundraising. And to our professional team on the ground who have advanced our work in the field, by carrying out our emergency programs and at the same time attending to our long term projects, working so hard with great devotion during this time of national emergency.

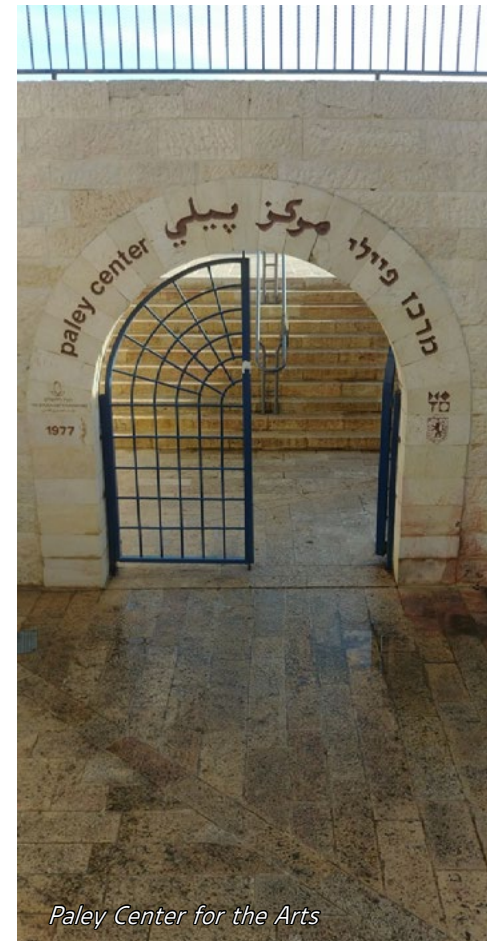

## EMERGENCY RESPONSE

In the emergency situation which began on October 7, normal, regular routines were disrupted and have not yet returned to normal. For many years, the Jerusalem Foundation has stood together with many community organizations and agencies across Jerusalem to build a strong civil society network in the city. In immediate response to the widespread tragedy, with the help of friends in Israel and around the world, we created an emergency fund to support this network's efforts to respond to the needs of all those affected by these disastrous events.

### Double Impact

As the emergency became a routine of its own, one project has become most important. Double Impact has provided relief simultaneously for refugees and Jerusalem's vulnerable populations while also supporting Jerusalem's leading cultural, community, sports and leisure institutions. Jerusalem is blessed with an abundance of Israel's most important sites and institutions, yet many of these are facing serious financial crisis due to the war. Double Impact provides the opportunity for the thousands of refugees and members of vulnerable populations in Jerusalem to enjoy the city's cultural sites, all while ensuring that these sites can weather these extraordinary times.

## Shared Society

The Learning Together in Jerusalem program brings together Jewish and Arab school children and faculty to socialize, learn together and engage in dialogue. In the framework of the project, dozens of specialized training sessions brought school principals and teachers from Jewish and Arab schools together for dialogue, learning and shared educational activities. In the past year, 110 schools & thousands of principals, teachers & pupils have been involved.

The events of October 7, 2023 and the subsequent war, changed the reality of life in Israel. Efforts to conduct and enhance shared living in the city were undermined and the project's Jewish-Arab encounters and shared educational activities came to a halt. However, there are courageous people who are still committed to the shared vision. The Jerusalem Foundation and its partners, the Jerusalem Municipality, are advancing various activities toward the rehabilitation of the Learning Together in Jerusalem program, through crisis management tools to repair the rift between Jews and Arabs and promote positive discourse with the understanding that we all do need to live together even in times of crisis.

## THE JERUSALEM FOUNDATION INNOVATION FUND

## FUTURE LEADERSHIP

The community service leadership gap year program in Jerusalem established by the SAHI (Youth Hesed Patrol) organization and the Jerusalem Foundation, trains high school graduates from marginalized and at-risk populations to become agents of change in their home communities. Through the program, participants work where help is needed with Jerusalem special needs children and in Jerusalem community centers, while also learning about leadership, the city of Jerusalem and Israeli society.

**The Jerusalem Scholarship Fund** distributed more than 2,000 scholarships to students who volunteered, each giving 140 hours of their time to a variety of non-profit organizations and civil society institutions. The aim of these scholarships is to assist students, encourage them to study at Jerusalem's higher education institutions and connect them with Jerusalem and its residents.

**The George Pinto ('Kayma') Jerusalem Leadership Fellows Program** – the Jerusalem Foundation's distinguished doctorate fellows' program (with 18 fellows) completed three years of activities and opened the 4th cohort.

**East Jerusalem Social Workers Program** – creating the next generation of social workers in East Jerusalem by providing tuition and a special incubator for each cohort to succeed and to find employment following graduation.

**Jerusalemites for Jerusalem Program** – A gap year program for young Jerusalem residents encouraging them to stay in Jerusalem after their military service by placing them in positions volunteering and becoming part of Jerusalem's civil society.

**The Maimonides Jerusalem Young Leadership Prize** – Awarded this year to Yael Berman-Domov, CEO of Tene Yerushalmi. Tene Yerushalmi encourages Jerusalem's young people to put down roots in Jerusalem by providing job search support as they begin building their careers and helping them become a part of Jerusalem's next generation of leadership.

**The Social Impact Fund (Keren Lee)** – established by Israeli donors to support young Jerusalemites with non-profit startup Jerusalem projects or the expansion of existing sustainable initiatives, funded the following 9 projects in 2023: Bar Café Beit Hakerem, The Trampolina, Jerusalem Fridays in Nature, HaMiffal Showroom, Spectrum, the Lounge at Mishkenot Sha'ananim, HaMiflezet Pub, HaPoel Jerusalem and the Secular Yeshiva.

**Impact Israel Scouts** – providing special leadership training for in-depth community work and cooperation with the local community center for the youth movement's branches in peripheral areas, transforming the branches into strong community forces in the neighborhoods.

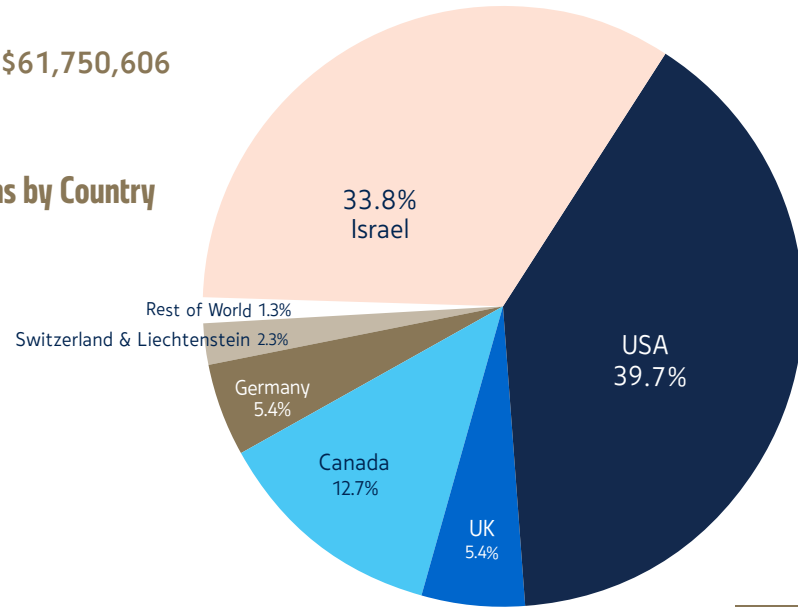

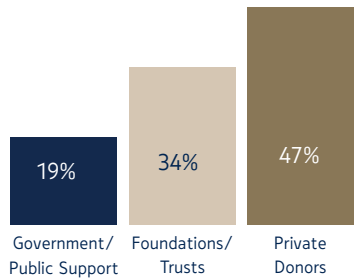

### Contributions by Country

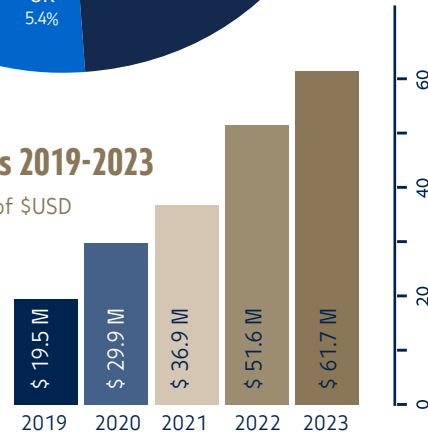


### Contributions by Type of Donor



### Donations 2019-2023

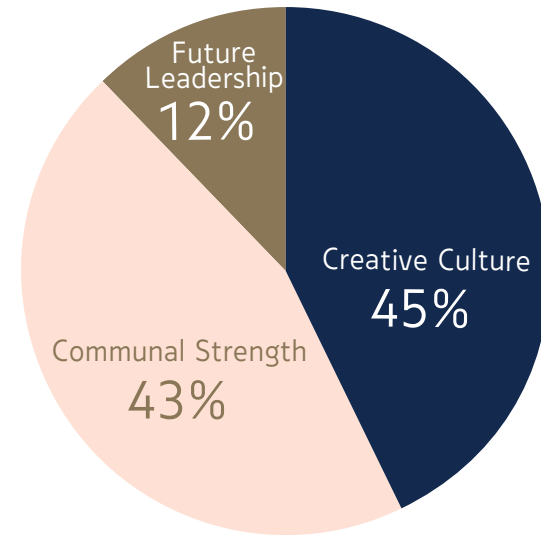

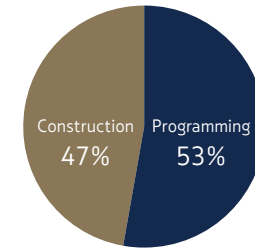
## EXPENDITURES

### Programming Expenditure by Category

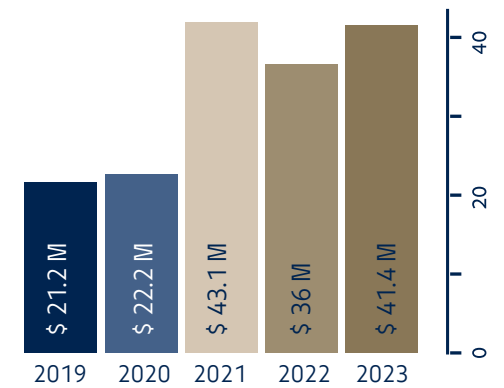


### Expenditure by Type of Project
